- Report immediately any equipment malfunctions to Diagnostic Imaging manager.
- Log completed radiological procedures, complete paperwork accurately and on time relaying information to reading physicians in a prompt manner.
- Perform In Home Sleep Studies. Must be able to set up and demonstrate home sleep study procedures with patient in a professional manner. Answering patient questions so that an accurate test can be recorded.
- Perform both CT and X-ray exams. Must be able to perform procedures with patients in a professional manner. Answering patient questions so an accurate test can be completed.
- Perform EKG accurately recording data and relaying to reading physician. Promptly delivering finalized report to ordering physician
- Be proficient in medical record requests, providing records to providers, patients and insurance companies as requested. Monitor patient recalls and notifications.
- Provide coverage for the radiology scheduler when directed.
- Makes suggestions to improve work methods
- Comply with all federal/state regulations (compliance timeframes, HIPPA, etc)
